PLAN No. 1

COMPLETE ANNUAL BURNER CHECKUP. (1) Cleaning, lubrication and adjustment of your burner. (2) Checking of oil strainers or filters. (3) Inspection and necessary adjustment of burner controls. (4) Cleaning of boiler or furnace. (5) Inspection or cleaning of combustion chamber. (6) Cleaning of smoke pipe. (7) Inspection of heel of chimney and cleaning if necessary. This is for Robertson Fuel Oil to perform an annual burner maintenance only. The allotted time for the annual burner maintenance is approximately one & one half (1½) hours. Any additional work performed (not shown below) will be billed for time, at our prevailing rate, plus materials. Required service performed after our normal business hours will be invoiced at 1½ times our hourly billing rate.

PLAN No. 2

FURNACE CLEANING, ANNUAL BURNER CHECK-UP, ALL BURNER SERVICE CALLS AND PARTS REPLACEMENT. Under Parts Insurance we will repair or replace Defective Parts of your Oil Burner, as listed below, for the entire heating season from date of signing to May 31st. (Exception: oil tank runouts; see conditions below).

CONDITIONS

The heating service plans outlined herein are subject to the following conditions:

Customer agrees to purchase fuel oil from Robertson Fuel Oil during the entire term of this agreement and the purchase and use of fuel oil from any supplier, other than Robertson Fuel Oil, immediately renders the terms of this agreement Null and Void and further, any monies paid to the supplier under the terms of this agreement are non-refundable to customer.

This agreement is void if the buyer permits any persons other than our employees to render service to the equipment except as instructed by us.

This agreement does not cover priming/starting of heater after runout if runout is due to customer negligence or delayed delivery due to non-payment.

This agreement does not cover parts damaged by water, fire, act of God, accident, tampering or abuse.

This agreement does not cover oil tank freeze-ups or liability for injury or damage resulting from the same.

Our obligation to furnish any parts is subject to their availability through normal sources of supply.

This agreement includes only repair and replacement of parts specifically listed which are defective due to normal wear and may include use of new, used, or reconditioned parts.

This agreement does not cover liability for injury or damage resulting from defects in, or the operation or non-operation of, customer's burner or its appurtenances or any other equipment, nor does it cover liability for loss or damage resulting from delay or failure to perform hereunder due wholly or partially to labor disturbances, fires, lack of material, governmental regulations, or any causes beyond our control.

Where more than one circulator is used, this agreement covers only circulator used for living room circuit.

This agreement does not cover humidifiers, electronic air cleaners, water feed valves, zone valves, circulator bearing assemblies, pressure relief valves, automatic air vents or ECM blower motors.

An additional labor charge will apply if system requires draining or purging for any reason; including the replacement of parts listed in this contract.

PARTS USED FOR HEATING AND COOLING ARE COVERED DURING HEATING SEASON ONLY.

This agreement contains the entire agreement of the parties hereto and there are no promises, terms, conditions or obligations other than printed herein.

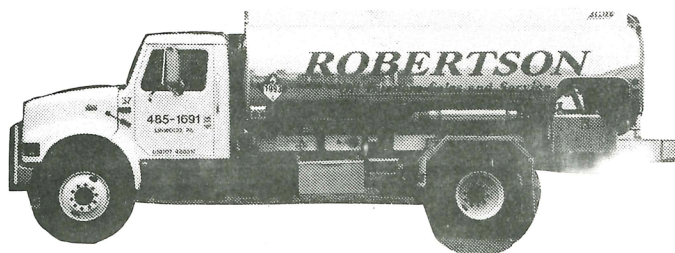
